Learning Objectives:

This class will examine the legal regulation of sex and reproduction from the 19th century through the present. We will explore specific regulations, as well as the policies behind these regulations. The class will look at who is subject to sexual and reproductive regulations, who is exempt and how that has or has not changed. We will then examine and analyze the many new reproductive laws and policies that have been passed or proposed after the Supreme Court's decision in Dobbs. By exploring the history of reproductive regulation in America, this course seeks to better equip students to understand and analyze the scope, purpose and legality of these new reproductive laws.

Course Materials:

The majority of the readings for class will be from the *Cases on Reproductive Rights and Justice Casebook*, 2nd edition (Murray, Luker). Additional materials are available through the class Twen page under the "weblinks" tab, or "additional materials" and through Westlaw.

Assessments:

Students will write three 7-10 page legal analysis/ policy papers. The papers will count for 70% of the course grade. Class participation will count for 20% of the course grade. In class presentations will comprise 10% of the final course grade.

Attendance:

I will take attendance in class. You do not need to inform me of any absences. However, I will expect you to get the class notes and be prepared for class when you return. Students who miss more than 10% of the course's class periods will need to obtain a waiver from the Associate Dean. Students who miss more than 30% will not receive credit for the class. Legislation/Policy Papers requirements:

If possible pick one state and use it for all three papers

Paper one will focus on a law regulating reproduction that has been enacted or proposed since the *Dobbs* decision (preferably one enacted in the past year). In this paper students will be expected to explain the law, how it was enacted, why it was enacted, the social and economic implications, the potential legality of the law, any ancillary legal questions raised by the legislation, and who will be most impacted. (Note such legislation can be laws that restrict access to abortions, birth control or other reproductive issues or laws passed to protect access to such care)

Paper two will describe a legal challenge to one of the newly enacted post-Dobbs laws. This paper can be written as a case note if the case has already been decided or you can discuss the challenge using the briefs that have been filed. In the paper, explain the legal challenge, the court's decision or likely decision, whether you agree or disagree as a matter of legal interpretation, whether the case is likely to be appealed, and what the issues on appeal will be.

Paper three is a policy paper. Using what you have learned from the course, discuss the purpose behind one/a group of post-Dobbs reproductive regulations. Explain how the current fights over these regulations fit into the history of reproductive regulation and how the current regulations differ from previous reproductive regulations and restrictions. The paper should cover some of the following: where you see reproductive regulation headed in the future, what challenges it will face, how these challenges might fare, the pros and cons of reproductive regulation, how such regulations will affect certain groups specifically, (e.g. women, LGBTQ+, African Americans, low income, religious minorities) the types of regulations you would like to see enacted or not and why, the likely public reaction to such regulations as well as the effect of such regulations on states' rights, federalism, democracy etc..
